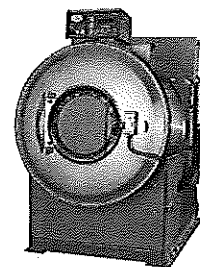

PEROXIDE 27% is a bleaching agent for laundry. It is very effective to remove tough stains from fabrics. It prevents the yellowing or the greying of white fabrics. It is safe for colors.

DIRECTIONS FOR USE

Use 1 to 3 oz (28 to 85 ml) of product per 50 lb (23 kg) of laundry at temperature of 160 to 180 °F (71 to 82 °C), with a low water level, during 8 to 10 minutes or according to specifications of your representative. Avoid contamination of food. All laundered fabrics and all surfaces subject to food contact must be rinsed with potable water before re-use.
